(ii) Deficiencies for compliance :

- (a) Deficient teaching staff to be appointed and approval shall be taken by the University.
- (b) Master time tables did not reflect O.W. No, Date of implementation, Teachers name. 1st BAMS T.T. shows College starts by 9.30 AM but classes starts actually by 10.00 AM.
- (c) Annexure – V, uploaded by College is faulty so can't verify. Number of actual available instruments not given in annexure.
- (d) Anexure –VI uploaded by College is old format. Month wise Number of patients data not provided to committee.
- (e) Hospital Registration, MPCB, BMW certificates not provided to committee nor uploaded on website.
- (f) Indoor & Outdoor playground & facilities, Auditorium not available.
- (g) At the time of Fira visit to OPD by 10.00 AM, 9 patients registered in OPD register, entries are made by Inter.
- (h) At the time of Fira visit to Hospital only one staff nurse namely Sujata & one namely Rajesh Patil found on duty present.
- (i) Midnight Bed occupancy Register shows total 40 IPD patients for 08.07.2022 however, on bed actually 13 Male + 07 Female patients found (20).
- (j) Total OPD patients for 07/07/2022 are shown as 232 which did not match correctly with number of dispensing (119) & other OPDs register data seems FABRICATES RECORD of 07/07/2022 OPD.
- (l) P.C. at all OPDs found Non-functional so data at OPD cant's verify.
- (m) Radiology seen have a X-ray machine Non-functional, No technician, Labour room Non – functional since 2 years.
- (n) As per Annexure – VIII, total 40 teachers are shown as working teachers out of 40 Two are found Ineligible as teacher due to overage and seen remaining 38. Nine teachers were not present before Committee through all Day.
- (o) Last year bed occupancy is reputed by College as 4.93% due to COVID.
- (p) In interaction with students in conf manner they collectively made following serious allegation for which we recommend to call 4 students/class randomly at University Hst for interaction with Hon'ble V.C./Pro-V.C./Registrar (For genuine verification).
 - (a) Non availability of clinical material. -
 - (b) Non availability of full time teachers. } College sayed due to Corona Pandamic. Some problems are Pair 2 years.
 - (c) Non availability of cadaver for dissociation
 - (d) Non availability proper servicing at Hostels.
- (q) No ongoing reserch activity reported by College.
- (r) College website is not working.
- (s) It is mandatory for college to approve advertisement from the Special Cell of MUHS. Any advertisement, prior to Year 2019, will not permitted for recruitment process.
- (iii) Other :- Fees/-, Fine/Penalty/- (if any pending with College)

(iv) Other:

- a. The College shall submit Affidavit in the prescribed format as per Academic Council's Resolution No. 229/2013 (format attached).
- b. Those UG / PG qualifications that are not yet recognized by the Central Govt. it is mandatory for the College to apply to the Central Council through Central Govt. and


ensure that Permitted / Not Recognized qualifications are enlisted in "Recognized Qualifications", failing which University shall not grant Continuation of Affiliation to such courses from ensuing Academic Year & no student shall be admitted in such courses.

In view of above, I am directed to inform you that this is provisional affiliation to your college and as such you are requested to comply with the above mentioned deficiencies within the stipulated time without fail and submit compliance report. Compliance report will be verified by the University by re-inspection of your college.

Important Note:

- 1) This Continuation / Extension of affiliation is issued for the A.Y. 2022-2023 subject to the permission of NCISM / Govt. of India / Department of AYUSH, New Delhi and if the permission is ~~declined~~ by the said authorities, this Continuation / Extension of Affiliation will be treated as cancelled. The College is not authorized to admit the students for 1st Year of the course until receipt of permission of the NCISM / Govt. of India/ Department of AYUSH New Delhi.
- 2) The admission shall be done through the Competent Authorities only.
