Subject: - Grant of Conditional permission to Kisan Dnyanoday Mandal Gudge's Ayurved Medical College & Hospital Near Sambhajinagar (Aurangabad) Bye pass, Dhule road, Chalisgoan, Dist. Jalgoan-424101, Maharashtra (Inst. ID - AYU0162) for intake capacity with 50 seats in UG (BAMS) Course under section 28 of NCISM Act, 2020 for the academic session 2024-25 and issuance of Letter of Permission for increase intake capacity in existing UG (BAMS) Course from 50 seats to 100 seats from the academic session 2024-25 under section 29 of NCISM Act, 2020-regarding.

Sir/Madam,

With reference to the subject mentioned above, I am directed to inform you that in pursuance of the provision of National Commission for Indian System of Medicine Act, 2020, the Indian Medicine Central Council Act, 1970 (48 of 1970) has been repealed with effect from the 11th day of June, 2021. With effect from the said date, the Central Council of Indian Medicine constituted under sub-division (1) of section 3 of the Indian Medicine Central Council Act, 1970 (48 of 1970) shall stand dissolved. Now, in exercise of the powers conferred by sub-section (3) of the section 1 of the said Act, the Central Government hereby notifies that all the provisions of the National Commission for Indian System of Medicine Act, 2020 has been come into force with effect from the 11th day of June, 2021 and as per regulation 59 (2) of The National Commission for Indian System of Medicine ACT, 2020, Medical standards, requirements and other provisions of the Indian Medicine Central Council Act, 1970 and the rules and regulations made thereunder shall continue to be in force and operate till new standards or requirements are specified under this Act or the rules and regulations made thereunder. Further, the provision of concerned regulations which are inconsistent with the provision of NCISM ACT 2020 shall not be applicable.

- I am to refer to your application vide **Ref. No. AMC&H/4077/2023 dated 30.09.2023**, on the subject cited above and to verify the available facilities of teaching, non-teaching, hospital staff and other facilities available at your college namely **Kisan Dnyanoday Mandal Gudge's Ayurved Medical College & Hospital Near Sambhajinagar (Aurangabad) Bye pass, Dhule road, Chalisgoan, Dist. Jalgoan-424101, Maharashtra (Inst. ID - AYU0162)**, your college was visited on **27.12.2023 & 28.12.2023** for the issuance of **LOI for increase intake capacity in existing UG (BAMS) course from 50 seats to 100 seats from the academic session 2024-25** and Letter of Intent (LOI) has been issued to your college vide letter of **even no. dated 14.02.2024 for increase intake capacity in existing UG (BAMS) course from 50 seats to 100 seats under section 29 of NCISM Act 2020 from the academic session 2024-25.**
- The Medical Assessment and Rating Board for Indian System of Medicine (NCISM) had carried out an inspection of the college again on **09.05.2024 & 10.05.2024 through Hybrid mode** to assess the available facilities of teaching, non-teaching, Hospital staff, practical training and other infrastructure facilities available as a part of annual visitation **for issuance of conditional permission for intake capacity with 50 seats in UG (BAMS) under section 28 of NCISM Act, 2020 for the academic session 2024-25** and for issuance of Letter of Permission **for increase intake capacity in existing UG (BAMS) from 50 seats to 100 seats under section 29 of NCISM Act 2020 from the academic session 2024-25.**
- Further, in view of above assessment report and all other related documents were assessed in terms of the enforced regulations namely "the Establishment of New Medical College, Opening of New or Higher Course of Study or Training and Increase of Admission Capacity by a Medical College Regulations, 2019, the "Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Ayurveda Colleges and attached Hospitals) Regulations, 2016", provisions under the NCISM Act, 2020. **On careful examination of the assessment report following shortcoming/defect have been observed-**

a) **Availability of teaching staff is $\frac{\text{Available}}{\text{Required}} \times 100\% = \frac{40}{45} \times 100\% = 88.88\%$.**

4. Thereafter, the assessment report was placed in the **90th Board Meeting** of Medical Assessment and Rating Board for Indian System of Medicine (NCISM) held on **17.05.2024**. **Board observed that the college is not fulfilling the notified & approved criteria, However, the college is fulfilling the criteria required for issuance of permission as per the Regulation 3 (3) of MSR 2016. Hence, the Board decided that the college is fulfilling the basic eligibility criteria for grant of conditional Permission with 50 seats in UG (BAMS) for the academic session 2024-25 under section 28 of NCISM Act, 2020 and issuance of letter of Permission for increase in intake capacity in existing UG (BAMS) Course from 50 seats to 100 seats under section 29 of NCISM ACT 2020 from academic session 2024-25.**
5. Further, in accordance of the regulation **6 (3) (j) (ii)** of "Establishment of New Medical College, Opening of New or Higher Course of Study or Training and Increase of Admission Capacity by a Medical College Regulations, 2019 vide letter of even no. **dated 03.06.2024** a letter was sent to you to furnish fixed security deposit worth **Rupees 50 lakhs** for a period of five year in favor of National Commission fund for Indian system of Medicine. In response of the same college has furnished the fixed security deposit in favor of the National Commission fund for Indian system of Medicine of **rupees 50 lakhs** through online payment mode **RTGS Ref no. 252845368 transferred by Cheque No 166616 from college account no 11257607884 Pracharya Ayurved mahavidyalay Chalisgaon SBI Branch Chalisgaon Dist-Jalgaon (M.S) Dated 10.06.2024 and informed the same vide letter vide No. AMC&h/4726/2024 dated 10.06.2024 by an email dated 10.06.2024.**
6. **Therefore, Grant of Conditional Permission is issued to Kisan Dnyanoday Mandal Gudge's Ayurved Medical College & Hospital Near Sambhajinagar (Aurangabad) Bye pass, Dhule road, Chalisgaon, Dist. Jalgaon-424101, Maharashtra (Inst. ID - AYU0162) for intake capacity with 50 seats in UG (BAMS) Course under section 28 of NCISM Act, 2020 for the academic session 2024-25 and Letter of Permission (LOP) is issued for increase in intake capacity in existing UG (BAMS) course from 50 seats to 100 seats from the academic session 2024-25 under section 29 of NCISM Act 2020 and relevant regulations thereunder, subject to following conditions:**
7. It is further informed that minimum 15% of undergraduate seats of the **permitted intake capacity of 100 seats shall** be treated as all India quota. The counseling for seats under all India quota shall be conducted by respective counseling authority as designated by Central Government for A.Y. 2024-25 and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned Counseling Authority of that State/UT. **The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Government/NCISM for all India quota or the students admitted thereunder.**
8. Admissions made in violation of the above conditions will be treated as invalid and action will be initiated under NCISM Act & Regulations thereunder.
9. Further, as per Sub-section (7) of Section 29 of NCISM Act, 2020, The Medical Assessment and Rating Board for Indian System of Medicine may conduct evaluation and assessment of any University or medical institution at any time, either directly or through any other expert, having integrity and experience in medical profession, without any prior notice and assess and evaluate the performance, standards and benchmarks of such University or medical institution and if the college is found to be not maintaining the Minimum Essential standards as specified in the concerned Acts & Regulations then in accordance of Section 28 (1) (f) of NCISM Act, 2020 the issued permission of the college shall deemed to be withdrawn and denial of permission shall be issued by MARBISM for stop page of admission for that particular academic year or the subsequent year.
10. Discrepancies, if any, may be immediately brought to the notice of Medical Assessment and Rating Board for Indian System of Medicine, NCISM.
11. **The following requirements should be fulfilled by the college by 31st December, 2024 and send a compliance report to get permission for the academic session 2025-26: -**
 - i) All the requirements under the provisions of the NCISM Act, 2020 and relevant Regulations made thereunder should be fulfilled in toto.
 - ii) All the requirements of minimum standard of infrastructure and teaching & training facilities as specified in MES (Assessment & Rating for Undergraduate Ayurveda Colleges and Attached Teaching Hospitals) Regulations, 2024.
 - iii) All the requirements of the National Commission for Indian System of Medicine (Minimum Standards of Undergraduate Ayurveda Education) Regulations, 2022.

iv) **The shortcoming mentioned in point no 3.**

12. This permission for increase in intake capacity in existing UG (BAMS) course from 50 seats to 100 seats from the academic session 2024-25 as stated above for the first admitted batch of 2024-25 session, will be valid till such time as the first batch of students admitted against these courses appear for the first final examination of the said courses and at that time, the College authorities may take up the matter for recognition of the qualifications under Section 35 of the NCISM Act 2020.
13. The fulfillment of the conditions given above may be made within the time period specified and compliance report should be submitted by the college to President, Medical Assessment and Rating Board for Indian System of Medicine. The Medical Assessment and Rating Board for Indian System of Medicine will verify that the conditions have been fulfilled for considering the permission for the academic session 2024-25.

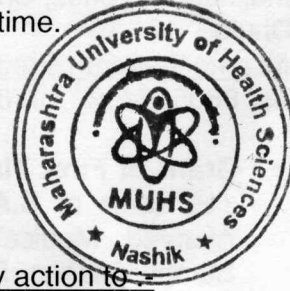
Sir / Madam,

As per provision of section 65 (4) of Maharashtra University of Health Sciences Act 1998, I am directed to inform you that, on the basis of the Local Inquiry Committee report and permission from Academic Council vide Resolution No. 204/2024 dated 20.09.2024, the Hon'ble Vice Chancellor is pleased to grant the First Time Affiliation to **Kisan Dynanoday Mandal Gude's, Ayurved Medical College & Hospital, Dhule Road, Near Chhatrapati Sambhajinagar Bypass, Chalisgaon, Dist. Dhule (Maharashtra)** for the Academic Year 2024-2025, for increase in intake capacity from 50 to 100 seats of B.A.M.S. (UG) Course by the following due procedure.

However, the affiliation is subject to the following conditions :-

- 1) Fulfilment of norms and conditions laid down by Central Council of Indian Medicine / National Commission for Indian System of Medicine, (NCISM) and Govt. of India.
- 2) Rules and Regulations made by the Govt. and the University, as amended from time to time, will be binding on the College.
- 3) The college should obtain the permission for admitting the students from the Admission Regulating Authority, Mumbai.
- 4) The college should obtain approval of fee schedule for the admission of the students from the Fee Regulating Authority, Mumbai

- 5) The college should obtain approval / recognition of teachers from Maharashtra University of Health Sciences, Nashik.
- 6) This First Time Affiliation to increase in intake capacity from **50 to 100** seats of **B.A.M.S.** (UG) course is valid for Academic Year **2024-25** only.
- 7) The next batch of students shall not be admitted unless Continuation of Affiliation of MUHS, is obtained by college/Institute.
- 8) The college shall not admit the students for the Academic Year **2024-25** after the cut-off date prescribed by the CCIM / (NCISM), New Delhi.
- 9) The students shall be admitted only after obtaining the permission of concern council & competent Authority of the State Govt.
- 10) It is mandatory for the College / Institute to register on AISHE portal and submit the required data on AISHE portal from time to time.
